SITE EVALUATION REQUIREMENTS

Submit completed Application for Site Evaluation with:

1. \$300 fee. Cash, Check or Credit Card accepted. Make check payable to LFCHD.
2. Detailed construction plans
3. If the site is less than 10 acres you must provide:
 - a. Copy of the recorded deed
 - b. Signed copy of the most recent recorded plat, if such exists
4. Copy of plot plan or survey including:
 - a. Size and dimension of lot
 - b. Approximate location of house, driveway, garage and any out buildings
 - c. Location of any utilities, wells, ponds, streams, easements, roads, drives or right-of-ways if present
 - d. Location of any existing septic system

BACKHOE PITS ARE REQUIRED

- Sites need to be mowed, but not cleared
- Applicant provides backhoe for the site evaluation
- The location designated for the septic system must be protected from disturbance
- We strongly recommend you use a certified installer. They will schedule the site evaluation with our office. Appointments can be scheduled within a week under normal weather conditions.

Conditions of the Approval to install Onsite Sewerage System

1. This approval is NOT transferable to another person or to another location
2. The subsurface sewerage system is to be installed in the designated location and as designed on this approval and/or on the attached approved plans
3. Any deviation in the location of the system must be requested in writing from the owner and must be approved in writing by the Lexington-Fayette County Health Department
4. The area designated for the sewage drain field cannot be used for driveways, parking areas, patios, or any other type of construction. The drain field area is to be planted in grass or similar vegetation.
5. Roof and basement drains shall not be discharged into any part of the sewerage system, but shall be directed to a part of the lot away from the drain field area.
6. This approval becomes null and void if any portion of the drain field area is graded before installation of the drain field or if any of the soil is removed from the drain field area.
7. This approval shall be null and void if any information submitted to the Lexington-Fayette County Health Department, used in approval of land has been falsified or given incorrectly.

Uses and Limitations of This Approval

1. This approval CAN be used to obtain a building permit and an onsite sewerage system permit
2. This approval CANNOT be used to install an onsite sewerage system or any part of the system.
3. If construction has not been completed within ONE YEAR from the date issued, this approval becomes null and void
